## System Maintenance

**Down Period:** 12 Mar 2022 to 13 Mar 2022

All "Ready for Payment" status will be removed from the system.

Draft applications have to be submitted by **11 Mar 2022, 2100 hrs.**

## Revised GoBusiness Licensing Application Status

Additional GoBusiness Licensing application status introduced to **reflect** the progress of the application.

## Auto-submission for Renewal Application

Renewal applications for Halal licences expiring **31 Apr 2022** onwards will be **automatically submitted** by the system.

## Offline Payment

Offline payment details **for multiple applications** can be submitted via GoBusiness Licensing Portal.

Virtual Brands are establishment names that **only exist in online platforms**. Applicants for Eating Establishment and Food Preparation Area schemes can submit Virtual Brands in the online application form.

## New Amendment Categories

**NEW!** Add product or ingredient to existing records (**For Product and Whole Plant Scheme**)

**NEW!** Amend menu or ingredient for 2 or more outlets (**For Eating Establishment and Food Preparation Area Scheme**)

## Manufacturing Company Details

Brand Owners under Product Scheme to indicate contract manufacturer details to provide better clarity for more efficient processing.

The certificate expiry date for Brand Owners will be streamlined with contract manufacturer certificate expiry date.
