## FOREWORD

---

### **Majlis Ugama Islam Singapura**

The Majlis Ugama Islam Singapura (Muis), also known as the 'Islamic Religious Council of Singapore', was established in 1968 pursuant to the enactment of the Administration of Muslim Law Act. Muis is a statutory board under the Ministry of Culture, Community and Youth and is in charge of Muslim affairs in Singapore. Among others, Muis issues Halal certificates and regulates the Singapore Halal industry. More information on Muis' roles and responsibilities are available at [www.muis.gov.sg](http://www.muis.gov.sg).

### **Administration of Muslim Law Act**

88A – (1) The Majlis may issue halal certificates in relation to any product, service or activity and regulate the holders of such certificates to ensure that the requirements of the Muslim law are complied with in the production, processing, marketing or display of that product, the provision of that service or the carrying out of that activity.

(3) The Majlis may, in issuing a halal certificate, impose such condition as it thinks fit and may at any time vary, remove or add to such condition.

(5) Any person who, without the approval of the Majlis:

- i) issues a Halal certificate in relation to any product, service or activity; or
- ii) uses any specified Halal certification mark or any colourable imitation thereof,

shall be guilty of an offence and shall be liable on conviction to a fine not exceeding \$10,000 or to imprisonment for a term not exceeding 12 months or both

(6) The Majlis may, in granting approval to any person to issue any Halal certificate or to use any specified Halal certification mark, impose such condition as it thinks fit and may at any time vary, remove or add to such condition.

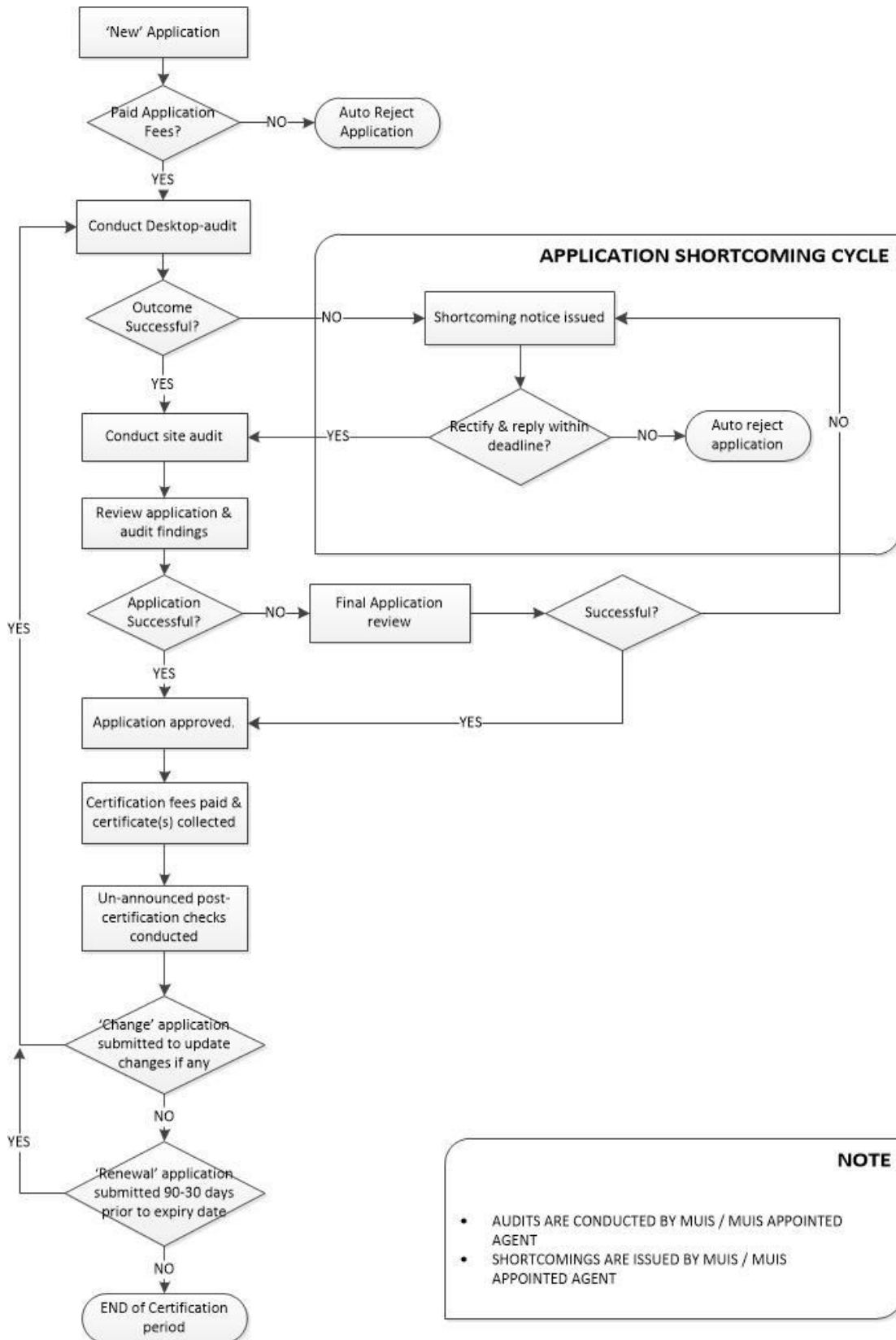
(7) The Majlis may revoke or suspend its approval granted to any person to issue any Halal certificate or to use any specified Halal certification mark if that person fails to comply with any condition imposed under subsection (6).

## HALAL CERTIFICATION CONDITIONS

<b>1. GENERAL INFORMATION</b>		
1.1	The conditions set out in this document shall hereinafter be referred to as the "Muis Halal Certification Conditions". All annexes to these Muis Halal Certification Conditions shall be deemed to be incorporated in and form an integral part hereof. Words or phrases in these Muis Halal Certification Conditions that are defined in Annex C – Glossary shall bear their defined meaning unless the context otherwise requires.	<b>Muis Halal Certification Conditions</b>
1.2	All companies / establishments applying for a Halal certification from Majlis Ugama Islam Singapura (Muis), may, upon fully complying to the Muis Halal Certification Conditions, be issued a Muis Halal certificate (the "Halal certificate") and allowed the use of Muis Halal certification mark (the "Halal certification mark") upon the terms and subject to conditions provided therein.	<b>General information</b>
1.3	All applications are subject to the prevailing Muis Halal Certification Conditions.	<b>Subject to Conditions</b>
1.4	The applicant is deemed to have agreed to divulge its company's information to Muis and/or Muis-appointed agent and adhere to the Muis Halal Certification Conditions upon submitting an application to Muis.	<b>Agreement by applicant</b>
1.5	All applications shall be processed with strictest confidence.	<b>Confidentiality of applications</b>
1.6	The Product scheme shall be applicable to selected products, which are manufactured or partly processed / packed in Singapore.	<b>Product Scheme eligibility</b>
1.7	The Whole Plant scheme shall be applicable to manufacturing facility, including all products manufactured therein, in Singapore.	<b>Whole Plant Scheme eligibility</b>
1.8	The Product scheme shall NOT be applicable to: <ul style="list-style-type: none"> <li>1. Trading items manufactured outside the applicant's premises;</li> <li>2. Products that are manufactured overseas without any further processing in Singapore;</li> <li>3. Manufacturing facility that has a valid Halal certificate under the Whole Plant scheme, which is not due for renewal.</li> </ul>	<b>Product Scheme eligibility</b>

Manufacturing facility operating outside Singapore;</li> <li>3. Brand owner of contract-manufactured products;</li> <li>4. Contract manufacturer;</li> <li>5. Poultry abattoir certified under Poultry scheme;</li> <li>6. Manufacturing facility which provides Halal food displayed in food warmers located at external premises;</li> <li>7. Manufacturing facility that has a valid Halal certificate under the Product scheme, which is not due for renewal.</li> </ol> <p><u>Note:</u> The applicant may, however, switch from Product to Whole Plant scheme, and vice versa, anytime during the submission of Renewal application.</p>	<b>Whole Plant Scheme eligibility</b>
1.10	<p>The scope of certification shall include (without limitation):</p> <ol style="list-style-type: none"> <li>1. Transportation, receiving, storage and handling of raw materials and processing aids.</li> <li>2. Production, packing, labelling, storage and transportation of finished products.</li> <li>3. Washing and handling of equipment(s).</li> </ol>	<b>Scope of certification</b>
<b>2. APPLICATION REQUIREMENTS</b>		
2.1	The applicant shall read, understand and adhere to the Muis Halal Certification Conditions upon submission of the application.	<b>Advice before submitting application</b>
2.2	Any request for waiver of the Muis Halal Certification Conditions shall be submitted in writing using the form provided by Muis.	<b>Request for waiver of Conditions</b>
2.3	All applications for the issue of a Halal certificate by Muis shall be made through the Muis eHalal System (MeS) at <a href="https://www.halal.sg/ehalalv2/login.aspx">https://www.halal.sg/ehalalv2/login.aspx</a> . Incomplete and/or incorrect entries on the MeS shall disqualify the application.	<b>Mode of application submission</b>

2.4	<p>The applicant shall submit a New application if:</p> <ol style="list-style-type: none"> <li>1. Its current location has not been previously Halal-certified by Muis;</li> <li>2. It has expanded manufacturing operation in another location and intends to obtain Halal certification for the products manufactured in the other location;</li> <li>3. Its existing Halal certificate has expired;</li> <li>4. It is not able to submit a Renewal application via the MeS;</li> <li>5. Its previously submitted application was rejected;</li> <li>6. Its Halal certificate had been cancelled.</li> </ol>	<b>Submission of New application</b>
2.5	<p>The applicant shall submit a Change application if it is an existing Halal certificate holder and has updates to be made to the application details submitted earlier through the MeS (e.g. contact information, particulars of Muslim personnel, names of product or menu items, details of raw materials, processing aids, and / or additives, etc.)</p>	<b>Submission of Change application</b>
2.6	<p>The applicant shall submit a Renewal application if it intends to renew its Halal certificate. Submission of Renewal application is only accepted by the MeS <u>90 - 30 days before expiry</u> of the existing Halal certificate. The applicant shall, however, submit a New application if the application is made <u>less than 30 days</u> before the expiry of existing Halal certificate and this is subject to a NON-REFUNDABLE application fee.</p>	<b>Submission of Renewal application</b>
2.7	<p><b>The applicant shall pay a NON-REFUNDABLE application fee by cash or cheque at Muis office or online through the MeS or any other means made available by Muis within 7 days of submitting its New application. Failing this, the application shall be automatically rejected without further notice. No application fee is required for Change or Renewal application.</b></p>	<b>Payment of non-refundable application fee</b>
2.8	<p>Details of all products, raw materials, additives and processing aids shall be declared through the MeS. These details shall include, but not limited to, the item description as well as names of the manufacturers, suppliers and Halal certification bodies.</p>	<b>Information required in Muis eHalal System</b>
2.9	<p>All raw materials, processing aids and additives declared shall be Halal and substantiated with either one or more of the following documents (Refer to <u>Annex A</u>):</p> <ol style="list-style-type: none"> <li>1. Halal certificates or Halal certification marks from Muis and/or Muis-recognised Halal certification bodies;</li> <li>2. Product specifications;</li> <li>3. Muis Halal questionnaire;</li> <li>4. Laboratory analysis report according to Muis' requirements.</li> </ol>	<b>Need to be Halal and substantiated with relevant documents</b>

2.10	<p>All products applied for certification by Muis shall reflect the exact names printed on the packaging (including brandname, product description and product code). Similar products bearing different brand names and/or product descriptions shall be treated as separate products.</p> <div style="border: 1px solid black; padding: 5px; margin-top: 10px;"> <p><u>Note:</u></p> <ol style="list-style-type: none"> <li>1. ABC Strawberry Milk and ABC Full Cream Milk are considered 2 separate products.</li> <li>2. ABC Tepung Terigu and ABC Wheat Flour are considered 2 separate products.</li> <li>3. Whole chicken (big) and Whole chicken (small) are considered 2 separate products if the word 'big' or 'small' is indicated on the packaging.</li> <li>4. ABC Strawberry Milk (1 Liter) and ABC Strawberry Milk (100 ml) are considered 1 product.</li> <li>5. Beancurd (small) and Beancurd (large) are considered 1 product.</li> <li>6. 2.11	<p>Where the same business name is used by the applicant and another entity/other entities under licence/franchise from the owner of the business name, the applicant shall submit halal certification applications for all entity(ies) concurrently.</p>	<b>Application for all chain / franchise outlets</b>
2.12	<p>In addition to the Product / Whole Plant scheme, the applicant shall also apply for:</p> <ol style="list-style-type: none"> <li>1. The Eating Establishment scheme if the manufacturing plant and food service / retail outlets bear the same business name (Not applicable to Product Scheme);</li> <li>2. Food Preparation Area – Central Kitchen scheme if the raw materials are semi processed by the applicant at a different unit / location;</li> <li>3. Food Preparation Area – Catering scheme if the premises provides catering services;</li> <li>4. Poultry Scheme if the abattoir slaughters Halal poultry to be sold as whole or cut pieces;</li> <li>5. The Storage Facility scheme if its products / raw materials are stored offsite;</li> <li>6. Short Term sub-scheme if the applicant / Halal certificate holder operates a temporary food stall at a bazaar, exposition, etc.</li> <li>7. Any other relevant scheme for related activities conducted offsite or onsite as deemed necessary by Muis.</li> <li>8. 2.13	<p>For contract manufactured products:</p> <ol style="list-style-type: none"> <li>1. The contract manufacturer shall be Halal-certified or have applied for Halal certification;</li> </ol>	<b>Requirements for contract-manufactured products</b>



	<p>2. Either the contract manufacturer or brand owner shall be the applicant if the product packaging bears both of their names;</p> <p>3. The brand owner shall be the applicant if the product packaging bears only the brand owner's name;</p> <p>4. The brand owner and contract manufacturer shall submit application under the Product scheme.</p> <div style="border: 1px solid black; padding: 10px; margin: 10px 0;"> <p>Note:</p> <p>1. 2.14	<p>For submission of Halal application via the MeS, the applicant shall:</p> <ol style="list-style-type: none"> <li>1. Register a MeS account using the same company name as that reflected on the product packaging;</li> <li>2. Submit a single MeS ticket for all products to be Halal-certified that are manufactured at the same premises;</li> <li>3. Submit multiple MeS tickets, under the same MeS account, for all products to be Halal-certified that are manufactured at separate locations (i.e. If applicant operates / engages 2 or more contract manufacturers at separate venues, then 2 or more MeS tickets shall be submitted under the same MeS account);</li> <li>4. Submit multiple MeS tickets, under the same MeS account, for different certification schemes.</li> </ol>	<p><b>Accounts / tickets created in Muis eHalal System</b></p>
2.15	<p>The applicant shall declare any other businesses operated by the applicant or its holding company to Muis.</p>	<p><b>Declaration of other businesses or holding company</b></p>
2.16	<p>The applicant may be advised to change the scheme and/or subject to additional requirements as Muis deems fit.</p>	<p><b>Additional requirements if necessary</b></p>

2.17	The applicant shall take ownership and bear responsibility for its application at all times.	<b>Ownership and responsibility</b>
<b>3. GENERAL CERTIFICATION REQUIREMENTS</b>		
3.1	The applicant shall be licenced by the National Environment Agency (NEA), Agri-food & Veterinary Authority (AVA) or Health Sciences Authority (HSA), whichever is applicable.	<b>License by NEA, AVA or HSA</b>
3.2	The applicant shall clearly demarcate the scope of certification by labelling and submitting a copy of the floor plan to Muis and/or Muis-appointed agent. This shall also be kept at the premises at all times for audit purposes.	<b>Demarcation of scope of certification</b>
3.3	The applicant shall ensure the scope of certification is clearly segregated with proper partitions including the entrance, preparation area and/or storage area etc.	<b>Segregation of scope of certification</b>
3.4	Products, menu items, raw materials, additives, processing aids and packaging materials that are undeclared, doubtful, non-Halal and/or Najis according to Shariah law shall not be stored, used, sold, offered for sale and/or brought into the scope of certification.	<b>No undeclared, doubtful and/or non-Halal items</b>
3.5	There shall be no cross-mixing of Halal products, menu items, raw materials, processing aids, additives and packaging materials with those that are doubtful, non-Halal and/or Najis according to Shariah law.	<b>No cross-mixing</b>
3.6	Every product, raw material, additive and processing aid stored, used, sold and which is within the scope of certification shall be properly packed, sealed and labelled with the product description, product code (if any), manufacturer's name and plant address for traceability and audit purposes.  <div style="border: 1px solid black; padding: 5px; margin: 10px 0;"> <p><u>Note:</u> It is advisable that products, raw materials, additives and processing aids that are Halal-certified bear a Halal certification mark on the packaging for ease of verification.</p> </div>	<b>Proper packing, sealing and labelling</b>
3.7	A laboratory analysis report according to Muis' requirements may be required by Muis and/or Muis-appointed agent to confirm that the products, raw materials, additives and/or processing aids are Halal. The selection of laboratory and procedure for product sampling shall be decided by Muis. The applicant shall bear all costs of the laboratory testing.	<b>Laboratory analysis</b>
3.8	All production lines, kitchen areas, cold rooms, chillers, equipment, crockery, utensils, dishwashing facilities, etc. that are used in the handling of Halal products, raw	<b>Ritual cleansing</b>

	materials, processing aids and additives that have previously come into direct contact with pork, dog meat and/or their derivatives shall be declared and subjected to ritual cleansing by Muis and/or Muis-appointed agent.	
3.10	There shall be dedicated and clearly demarcated production lines, kitchen areas, storage areas, equipment, crockery, utensils and dishwashing facilities for the handling and processing of Halal products, raw materials, processing aids and additives.	<b>Dedicated and clear demarcation during handling and processing</b>
3.11	All Halal products, menu items, raw materials, processing aids and additives shall be physically segregated from those that are non-Halal or doubtful during transportation to the premises to which Halal certification relates.	<b>Physical segregation during transportation</b>
3.12	The applicant shall comply with the Singapore Muis Halal Quality Management System (HalMQ), comprising these 10 principles:	<b>Singapore Muis Halal Quality Management System (HalMQ)</b>
	<p><b>1. <u>Establish a Halal Team</u></b></p> <p>a. The Halal Team shall comprise the Halal Team Leader, the Muslim Representative and other members from multi-disciplinary background with relevant knowledge and expertise;</p> <p>b. Each Halal Team member shall be officially appointed and informed of his / her roles and responsibilities in the form of an Appointment Letter, which is signed by the Management and the Halal Team member as proofs of appointment and acceptance, respectively;</p> <p>c. The Halal Team Leader and Muslim Representative shall successfully complete a mandatory Halal training programme by Muis-appointed Training provider;</p> <p>The Terms of Reference of the Halal Team shall include developing a HalMQ plan as well as implementing and maintaining an effective Halal system. It shall also be responsible in ensuring that the applicant’s staff is aware of the Muis Halal Certification Conditions.</p> <div style="border: 1px solid black; padding: 5px; margin-top: 10px;"> <p>Note:</p> <ol style="list-style-type: none"> <li>1. For contract-manufactured products, the brand owner need not establish a Halal team but shall appoint a Company Representative to ensure that the products processed at the contract manufacturer’s plant comply with the Muis Halal Certification Conditions.</li> <li>2. Unless otherwise advised by Muis, franchise or chain outlets, food stations, shall form only one Halal Team.</li> </ol> </div>	<b>HalMQ 1 – Halal Team</b>

	<p><b>2. <u>Define the Product / Nature of Business</u></b></p> <p>The Halal Team shall maintain a list of all products as well as details of the raw materials, processing aids and additives stored within the scope of certification such as the names of their manufacturers, suppliers and agencies that certify the items as Halal.</p>	<p><b>HalMQ 2 – Product / nature of business</b></p>
	<p><b>2. <u>Construct &amp; Verify Flow Chart</u></b></p> <p>a. The Halal Team shall clearly identify every step involved in the relevant operations;</p> <p>b. The Halal Team should incorporate all these steps in a flow chart and confirm it against the actual operation by conducting on-site inspections.</p>	<p><b>HalMQ 3 – Flow chart</b></p>
	<p><b>4. <u>Identify Halal Threats &amp; their Control Measures</u></b></p> <p>a. Using the flow chart, the Halal Team shall identify and list all possible Halal threats at every step in the relevant operations;</p> <p>b. The Halal Team shall also identify and list the necessary control measures to eliminate these Halal threats.</p>	<p><b>HalMQ 4 – Halal threats and control measures</b></p>
	<p><b>4. <u>Determine Halal Assurance Points (HAPs), their Allowable Limits &amp; Prescribed Practices</u></b></p> <p>a. The Halal team shall identify the HAPs in operations that are vital for ensuring the Halalness of products.</p> <p>b. Allowable limits and prescribed practices shall be established for all HAPs.</p>	<p><b>HalMQ 5 – Halal Assurance Points</b></p>
	<p><b>6. <u>Establish Monitoring System for each HAP</u></b></p> <p>a. The Halal Team shall establish monitoring systems for each HAP, including who should act, when, how and what corrective actions shall be taken should there be a deviation from the specified allowable limits and prescribed practices.</p> <p>b. The monitoring system shall be able to detect any sign of loss of control at the HAP. Some HAPs may be monitored by quantitative measurements, e.g. voltage of stunning, or observation approach, e.g. Halal certification mark on packaging of raw material.</p> <p>c. Staff assigned at the HAPs, shall be given a proper briefing on the prevailing Muis Halal Certification Conditions for their information and strict compliance.</p>	<p><b>HalMQ 6 – Monitoring system</b></p>

	<p><b>7. <u>Establish Corrective Actions for each HAP</u></b></p> <p>a. Corrective action for each HAP has to be developed whenever monitoring indicates that a deviation from the allowable limit and prescribed practices has occurred.</p> <p>b. These corrective actions shall be able to control the HAP within its specified allowable limits and prescribed practices.</p> <p>c. A specific action plan shall also be developed to restore control and dispose of the affected product. Under such circumstances, it is essential that the Halal team is informed so that a clear chain of command can be issued.</p>	<p><b>HalMQ 7 – Corrective actions</b></p>
	<p><b>8. <u>Establish Documentation &amp; Record-keeping System</u></b></p> <p>The Halal team shall establish and maintain the following documentations and records for purpose of audit:</p> <p>General -</p> <ul style="list-style-type: none"> <li>• Licence from the National Environment Agency (NEA), Agri-Food and Veterinary Authority of Singapore (AVA) or Health Sciences Authority (HSA), whichever applicable</li> <li>• Floor plan indicating the scope of certification.</li> </ul> <p>Products / Raw Materials / Processing Aids / Trading Items -</p> <ul style="list-style-type: none"> <li>• Updated MeS Master-print listing the products, raw materials, processing aids and additives stored within the scope of certification</li> <li>• Product packagings</li> <li>• Copy of completed form provided by Muis stating the list of trading items</li> <li>• Declared and approved valid Halal certificates, questionnaires, specifications and/or laboratory analysis report for all raw materials and processing aids</li> <li>• 3 – 6 month records of purchase invoices and or delivery orders for all raw materials and processing aids. Monitoring systems;</li> <li>b. Personnel compliance to the HAPs operations;</li> <li>c. Deviations and effectiveness of corrective actions taken;</li> <li>d. Random sampling;</li> <li>e. Audit reports.</li> </ol>	<p><b>HalMQ 9 – Verify system</b></p>
	<p><b>10. <u>Review the Halal System</u></b></p> <p>The Halal system shall be reviewed periodically, at least once every year. However, an immediate review of the system is necessary when any of the following occurs:</p> <ol style="list-style-type: none"> <li>a. Control measures are ineffective;</li> <li>b. Change in the Halal Team;</li> <li>c. Changes are made to the monitoring schedules;</li> <li>d. Change in the operations;</li> <li>e. ## ANNEX C – GLOSSARY

<b>Administration of Muslim Law Act (AMLA)</b>	An Act relating to Muslims and to make provision for regulating Muslim religious affairs and to constitute a council to advise on matters relating to the Muslim religion in Singapore and a Syariah Court.
<b>Additive</b>	Substances added to food to preserve flavour or enhance its taste and/or appearance.
<b>Allowable Limit</b>	The value of a monitored action which separates acceptable from the unacceptable. Examples include voltage for stunning of animal, amount of ethanol, etc.
<b>Applicant</b>	Company / Establishment submitting an application for the purpose of Halal certification.
<b>Brand Owner</b>	Company which owns a product brand name. The company may manufacture or outsource the manufacturing of the product.
<b>Certificate of Achievement</b>	Certificate issued to someone who undergoes a Halal training programme organised by the Muis Academy and meets the assessment criteria designed for the programme.
<b>Change Application</b>	Application submitted via the MeS seeking approval for the changes to the previously approved Halal application.
<b>Competent Muslim Personnel</b>	Muslim personnel who has successfully completed the mandatory Halal training programme conducted by Muis Academy.
<b>Contract Manufacturer</b>	Company which manufactures products on behalf of another party. Also known as Original Equipment Manufacturer (OEM).
<b>Contract-manufactured Product</b>	Food or non-food product that is outsourced for manufacturing purpose.
<b>Control Measure</b>	Any action and/or activity required to eliminate Halal threats.
<b>Corrective Action</b>	Any action to be taken when the results of monitoring at the HAP indicate a loss of control.
<b>Documentation</b>	Written proof of step-by-step process documenting a routine or repetitive activity involved in the implementation of a Halal Quality Management System.
<b>Doubtful</b>	Items whose Halal status cannot be established.



<b>Express Application</b>	Application processing shall be initiated within 7 working days upon submission of a New application and payment of the non-refundable application fees. It does not guarantee the issuance of a Halal certificate within 7 working days.
<b>Food</b>	Includes drinks.
<b>Halal</b>	Means "Permissible". Halal, in relation to any product, service or activity, means the requirements of the Muslim law are complied with in the production, processing, marketing, display or carrying out, as the case may be, of that product, service or activity  Refer to the Singapore Muis Halal Standard on 'General Guidelines for the Handling and Processing of Halal Food' (MUIS-HC-S001) for more information.
<b>Halal Assurance Point (HAP)</b>	A step in an operation which, if controlled and monitored, shall eliminate the occurrence of a Halal threat. Examples include point of receiving of raw materials, point of animal slaughtering, etc
<b>Halal Team</b>	A group of appointed personnel responsible for implementing, monitoring and maintaining the Halal system, as well as ensuring that all requirements have been met in accordance with this document. The Team shall comprise management-appointed Halal Team Leader, Muslim Representative and members from multi-disciplinary background, who possess relevant knowledge and expertise.
<b>Halal Team Leader</b>	Management-appointed representative who heads the Halal Team and has attended a mandatory Halal training programme by the Muis Academy. The Halal Team Leader shall be someone who has the authority to implement the Muis Halal Certification Conditions and rectify any non-compliance immediately.
<b>Halal Threat</b>	The potential to render a product as non-Halal. Examples include cross-mixing of Halal and non-Halal raw materials, receiving of raw materials that are not prior-approved by Muis, etc.
<b>MeS</b>	Muis eHalal System which is the sole means of submitting an application for Halal certification.
<b>MeS Account</b>	Customer code generated by the Muis eHalal System (e.g. C1234). One business name generally has only one MeS account.
<b>MeS Ticket</b>	Ticket ID generated by the Muis eHalal System (e.g. T0123456). One business name generally has multiple MeS tickets.

<b>Monitoring</b>	The act of conducting a planned sequence of observations or measurements of control parameters to assess total conformance with specifications and requirements as stipulated in this document.
<b>Muis-appointed Agent</b>	Refers to Warees Halal Limited, a not-for-profit public company limited by guarantee within the Muis Group.
<b>Muis eHalal System (MeS)</b>	<p>Web-based software, launched in 2007, that manages both front- and back-end processing of Muis Halal applications. Among others, the MeS allows for online submission of applications, update of application details, payment of certification fees, real-time information on application status and automatic renewal reminders.</p> <p>The MeS is available on <a href="https://www.halal.sg/ehalalv2/login.aspx">https://www.halal.sg/ehalalv2/login.aspx</a></p>
<b>Muis Halal Certificate</b>	A certificate issued by Muis under Section 88A of the Administration of Muslim Law Act (Cap 3). "Halal certificate", in relation to any product, service or activity, means a certificate to the effect that the requirements of the Muslim Law are complied with in the production, processing, marketing or display of that product, the provision of that service or the carrying out of that activity.
<b>Muis Halal Certification Mark</b>	Refers to any certification mark specified by Muis for use in relation to any product, service or activity in respect of which it has issued a Halal certificate under Section 88A (1) of the Administration of Muslim Law Act (Cap 3).
<b>Muslim</b>	A person who professes the religion of Islam in accordance with the Shariah Law.
<b>Muslim Representative</b>	A member of the Halal Team who is a Muslim and has attended a mandatory Halal training programme by the Muis Academy. The Muslim Representative may or may not be the Halal Team Leader.
<b>Najis</b>	<p>Means "filth".</p> <p>Substances considered as filthy cannot be consumed by Muslims.</p>
<b>New Application</b>	Fresh application submitted for the purpose of Halal certification.
<b>Non-Halal</b>	Means "not permissible".

	Non-halal, in relation to any product, service or activity, means the requirements of the Muslim law are not complied with in the production, processing, marketing, display or carrying out, as the case may be, of that product, service or activity
<b>Normal Application</b>	Application processing shall be initiated within 14 working days upon submission of a New application and payment of the non-refundable application fees. It does not guarantee the issuance of a Halal certificate within 14 working days.
<b>Permanent Muslim Personnel</b>	Staff of a company / establishment who is a Muslim and employed on a full- and/or part- time permanent basis. It includes the owner of a company / establishment who is a Muslim.
<b>Prescribed Practise</b>	Religious procedures and/or norms that should be carried out and/or complied with. Example includes procedure of Halal slaughtering, etc.
<b>Primary email address</b>	Company email address in the profile page of the MeS and that of the Primary Halal Liaison officer in the Halal Liaison Officer page. 
<b>Processing Aid</b>	Any substance or material, not including apparatus or utensils, and not consumed as a food ingredient by itself, intentionally used in the processing of raw materials, foods or its ingredients, to fulfil a certain technological purpose during treatment or processing.
<b>Product</b>	Refers to any food and non-food substance or material, which may be unprocessed, semi-processed or fully-processed, that may be bought, used, manufactured and/or distributed by a company / establishment. Refers also to the stock-keeping unit.
<b>Raw Material</b>	Crude or processed material that can be converted by manufacture, processing or combination into a new and useful product.
<b>Record-keeping</b>	The act of retaining and maintaining data, files, evidence and/or past records.
<b>Renewal Application</b>	Application submitted to renew the status of the existing Halal certificate no less than 30 days prior to its expiry.
<b>Ritual Cleansing</b>	Purification of surfaces or utensils that come into contact with sources of 'heavy Najis' (swine, dog and their hybrid offsprings). Such surfaces or utensils should not be used in the preparation of Halal food except after purification by Muis and/or Muis appointed agent.

	<p>The purification procedure is as follow:</p> <ol style="list-style-type: none"> <li>i. Remove all traces of the Najis.</li> <li>ii. Prepare a mixture of water and earth.</li> <li>iii. Pour the mixture on the affected area.</li> <li>iv. Wash away the affected area with 6 pourings of clean water. If it is less than 6, the purification is not valid. If it is more than 6, the purification is valid.</li> </ol>
<b>Scope of audit</b>	<p>Specifies the focus, extent, and boundary of a particular audit. The scope can be specified by defining the physical location of the audit, the organizational units that will be examined, the processes and activities that will be included, and the time period that will be covered. Range of activities and the period (months or years) of records that are to be subjected to an audit examination, including the details of the menu, ingredients / raw materials, additives, processing aids etc., to establish traceability and the scope of operations of the applicant.</p>
<b>Scope of certification</b>	<p>The scope shall include but not limited to the entire process of procuring raw materials, processing aids, additives, storage, preparation, packing, transportation and delivery of the products.</p>
<b>Shariah Law</b>	<p>Islamic Law that is based on the Al-Quran (i.e. holy book of Islam), Al-Hadith (i.e. traditions of Prophet Muhammad, Messenger of Allah), and Ijtihad (i.e. the process of Islamic idea of independent thought) according to the Shafi'i or any one of the Hanafi, Maliki or Hambali School of Thoughts. A particular food becomes Halal or non-Halal by Shariah Law or Islamic Law if it is considered so through one of the abovementioned sources.</p>
<b>Shortcoming</b>	<p>Non-compliance with the Muis Halal Certification Conditions.</p>
<b>Short-term Stall</b>	<p>Temporary food stall at a bazaar, expositions, etc for which its principal premises / central kitchen is Halal-certified. It shall apply for the Short-term Stall sub-scheme under the Eating Establishment scheme.</p>
<b>Singapore Muis Halal Quality Management System (HalMQ)</b>	<p>A set of systems-based Halal certification requirements introduced in 2008. Pronounced as 'Hallmark', HalMQ is benchmarked against internationally-known standards such as ISO and HACCP.</p> <p>Refer to the Singapore Muis Halal Standard on 'General Guidelines for the Development and Implementation of a Halal Quality Management System' (MUIS-HC-S002) for more information.</p>

<b>Staff Pantry</b>	Refers to a dedicated room / area within the company used by staff for the preparation of food for personal consumption, and not for the purpose of storing or preparing products, menu items, raw materials, processing aids and packaging materials within the scope of certification.
<b>Trading Item</b>	Product that is not manufactured in the premises applied for Halal certification.
<b>Working day</b>	Refers to any day except Saturday, Sunday and Public Holiday.
