## LAUNCH OF NEW MUIS HALAL CERTIFICATION CONDITIONS (HCC) FOR PRODUCT / WHOLE PLANT SCHEME

The Islamic Religious Council of Singapore (Muis) is pleased to announce the launch of the new Muis HCC 2022 (Version 1.0) for **Product (PRO) / Whole Plant (WP)** scheme following Halal Engagement Session held virtually in November 2021.

- 2 Based on the inputs from the public consultation, the revisions to the HCC have been finetuned to improve transparency, efficiency and effectiveness of Singapore's Halal regulation.
- The Muis HCC 2022 (Version 1.0) will be effective from **1 September 2022**. The key changes for the PRO / WP scheme are listed below:

## i. Trading and contract manufacturing under WP scheme

Currently, establishments under WP scheme are not allowed to undertake trading and contract manufacturing.

From 1 September 2022, those under WP scheme will be able to engage in trading and contract manufacturing. This comes together with a change in certificate format. The Halal certificate for WP scheme will include a list of all Halal-certified products manufactured at the address reflected in the certificate.

## ii. Display of Muis Halal Certification Mark (MHCM) on warmers

Those under PRO / WP scheme providing Halal food displayed in food warmers located at external premises are currently not allowed to display the MHCM on the food warmers.

From 1 September 2022, display of MHCM on food warmers will be allowed, provided that the list of Halal-certified food products to be placed in the warmers are displayed on the warmers as well.

## iii. Change in requirement for presence of brand owner's representative

At present, it is stipulated for brand owner's representative to be present during certification (site) audit.









From 1 September 2022, it is no longer a requirement for brand owner to send a representative for the certification audit conducted at the contract manufacturer's premises.
